- Unique SSPT Rail System[™] provides solid-edge support, and facilitates safe patient transfers.
- Designated head and foot sections prevent installation errors.
- Top Cover is a 2-way stretch nylon which reduces heat buildup and provides a low shear surface that is anti-microbial and water-resistant.
- Concealed zipper and a Barrier Stop Over-Flap prevents liquids from contaminating mattress core.
- Meets Federal Fire Code CFR 16 part 1633.
