3.1 EMERGENCY OVERVIEW

Odor, Color, Grade: Reddish-brown liquid with a characteristic odor.

SECTION 7: HANDLING AND STORAGE

7.1 HANDLING

Keep away from heat, sparks, open flame, pilot lights and other sources of ignition. Ground containers securely when transferring contents. Wear low static or properly grounded shoes. No smoking while handling this material. Avoid breathing of vapors, mists or spray. Avoid static discharge. Avoid contact with oxidizing agents. Use general dilution ventilation and/or local exhaust ventilation to control airborne exposures to below Occupational Exposure Limits. If ventilation is not adequate, use respiratory protection equipment. Do not ingest.
