





#### **IMPORTANT INFORMATION**

#### General

The Brewer LiftMate Patient Lift is designed to safely assist patients onto and off of exam tables, beds and other medical devices without the need for manual lifting. The LiftMate is to be operated by qualified medical professionals trained in its use. Read and understand all operating instructions, safety information, and maintenance requirements contained in this manual prior to operating the LiftMate. Become familiar with all of the LiftMate's functions before using it with a patient.

The Brewer LiftMate Patient Lift is primarily used in examination rooms for safely lifting patients with mobility issues onto exam tables. The LiftMate is easily operated with a hand pendant. The platform height can be raised and lowered from 1" to 10".

The LiftMate is easily moved from room to room on casters. The casters are extended by the operator when moving the LiftMate is required. Casters are extended by pressing and holding the "Push And Hold To Move" button. Once the LiftMate is in the desired position, releasing the "Push And Hold To Move" button will cause the casters to retract. When the casters retract the LiftMate will be lowered, and rest on four rubber feet for stability. NEVER ALLOW THE PATIENT ONTO THE LIFTMATE WITH THE CASTERS EXTENDED.

Once the casters have retracted and the LiftMate is resting on all four feet, the patient may then step onto the platform. The patient then turns around so his/her back is toward the table. Once the patient is secure, the operator can then raise the patient to a height where he/she can be seated. The operator can then either extend the casters to roll the LiftMate away from the table, or LiftMate may be left in place depending on the type of exam and physician's preference.

When the examination is complete the LiftMate can be rolled back into position. Once the casters have retracted and the LiftMate is resting on all four feet, the platform can be raised to a height that is comfortable for the patient to step onto the LiftMate platform. NEVER ALLOW THE PATIENT ONTO THE LIFTMATE WITH THE CASTERS EXTENDED. Once the patient is on the LiftMate the platform can then be fully lowered allowing the patient to easily step back onto the floor.

To provide untethered mobility the LiftMate can be operated via battery power. However it is recommended that the LiftMate be plugged into a 120VAC wall receptacle whenever possible to maintain optimal battery power and life. Note: only plug the LiftMate into a receptacle capable of providing a minimum of 4 amps of current. Some pieces of medical equipment having auxiliary receptacles are not capable of providing enough power and will result in blown fuses. See the "Battery" section of this manual for more information on getting the most out of your LiftMate battery.

#### **Service**




Figure 2. LiftMate Orientation

#### Orientation

Left and right orientation on the LiftMate are designated by how the patient approaches the unit to step onto the platform. Front is the entry area, and back is the area that is positioned against the exam table. See Figure 2.

- Ensure that this manual is located near the LiftMate, or if possible permanently affixed to the unit.

Failure to follow instructions with this symbol could result in serious personal injury and/or damage to the unit.

DANGER indicates an imminently hazardous situation which, if not avoided, will result in death or serious injury.

WARNING indicates a potentially hazardous situation which, if not avoided, <u>could</u> result in death or serious injury.

## **WARNING**

- Do not perform any procedures while patient is on the LiftMate.
- Use 115 VAC, 60 Hz as noted on the rating label.
   Failure to do so may result in electrical shock to personnel and will result in damage to the LiftMate.
- Do not use the LiftMate in an explosive or oxygen enriched atmosphere. Failure to do so may result in serious personal injury or death.
- Charging the battery with any device other than through the Control Box on the unit may result in serious personal injury, damage to other LiftMate components, and/or premature failure of the battery.




- Do not use any power supply other than that listed on the rating label. Failure to do so may result in serious injury and/or equipment damage.
- This product has been evaluated with respect to electrical shock, fire, and mechanical hazards only in accordance with UL60601-1; IEC60601-1; CAN/CSA C22.2 No. 601.1

#### **Electromagnetic Interference**

This product is designed and built to minimize electromagnetic interference with other devices; however, if interference is noticed between another device and this product, remove the interfering device from the room or plug this product into an isolated circuit.

**WARNING** Never place any body parts between the Handrail Crossbrace and Shrouds, or under the front edge of the Platform.








**Patient and Operator:** Ensure that loose clothing, buttons, jewelry or other such items that can snag onto the LiftMate are kept clear of catch points

#### **Patient**

- Never put a patient on the LiftMate while casters are extended.
- Patient should only get on or off of the LiftMate when all four base feet are firmly on the ground.
- Do not allow patients to pull themselves up by using any part of the LiftMate.

# WARNING Please observe the following warnings (continued).

 Patient must stand in the center of the platform during the lift procedure. Never lean forward, backward or sideways beyond the area indicated by the dashed line.



- Do not allow more than one person on the LiftMate at a time.
- Ensure that the back of the LiftMate is pushed as close to the exam table as possible.
- Make sure that all exam table drawers, stirrups, attachments or other protrusions are pushed in to prevent damage.

#### Children, Caregivers and Untrained Personnel:

- Anyone not trained in the safe use of the LiftMate must not be allowed to operate it.
- Ensure that children and others are clear of the LiftMate at all times whether it is being operated or not.
- Never allow the patient to operate the LiftMate at any time.

#### Special Patient Situations:

- The LiftMate must not be used by patients to pull themselves up out of a wheelchair or walker.
- Do not use the LiftMate for patients that are unable to support their own weight.
- Never exceed LiftMate's maximum capacity of 500 lbs.

General: Please observe the following consideration.

- LiftMate must not be used to transport anything including patients.
- If battery fails while casters are up or down, plug into receptacle to recharge.

## **ACAUTION** Please observe the following cautions.

#### Patient:

- Never engage casters while patient is on the LiftMate.
- Always use the top center of the handrails for holding onto the LiftMate while getting on/off, or being raised or lowered.
- Patients must use caution when stepping up to get onto the platform to avoid tripping.
- When patient is on table, ensure that the platform is lowered below patient's feet before moving unit back to the table for dismounting.
- Patient must be facing away from the exam table and holding onto the LiftMate's handrails before raising the platform.
- Lower platform when not in use to minimize risk of inadvertent contact and possible leg injury.

**Special Patient Situations**: Walkers and canes may be used to get onto the LiftMate, but must not be used during lifting and lowering. **Power Cord:** Always wind up power cord when not in use and during transport of LiftMate.

### INSTALLATION

#### Unpacking

NOTE: Inspect all boxes and contents for damage. Report any damage to the carrier immediately.

## **A** CAUTION

- To avoid damaging the LiftMate's plastic or painted surfaces, DO NOT use a knife or other sharp object to open the packaging.




Figure 3. LiftMate Lift Points

- Lift only at points indicated in Figure 3. Do not lift at other points.
- Do not plug LiftMate into receptacle prior to removal of all packaging materials.
- 1. Cut and remove banding from shipping carton.
- 2. Remove lid.
- 3. Separate and remove the two carton halves.
- 4. Remove foam packing blocks.
- 5. Remove plastic bags from platform handrails.
- LiftMate weighs 105 lbs. Use two or more people to lift unit from lower carton tray. Use caution to not catch rubber feet on anything that may cause them to detach.



The LiftMate weighs approximately 105 lbs. Two or more people should assist in removing the Lift-Mate from the shipping skid. Also, use proper lifting techniques when lifting. Failure to do so could result in serious injury.

## **A** CAUTION

Do not lift LiftMate at any point other than the lift points indicated in Figure 3. Do not lift by shrouds, power cords, or hand pendant cords. Serious damage to the LiftMate, or personal injury may occur if attempting to lift unit at an undesignated lift point.

## **INSTALLATION (Continued)**

#### Getting the Most from the LiftMate Battery

NOTE: The LiftMate has protective circuitry to prevent the charge from draining to excessively low levels. Keeping the battery charged will ensure optimal service, while extending battery life to its fullest.

- When the charge in the LiftMate battery drops to a preset level the "LOW BATTERY" indicator light on the hand pendant will flash and the unit will beep when the any button is pushed. Plug LiftMate into a wall receptacle as soon as possible to recharge the battery.
- 2. When the charge in the LiftMate battery drops to a level that will cause battery life to shorten if use continues, all functions will stop. The unit will beep, and a steady indicator light on the hand pendant will appear if any hand pendant button is pushed. Plug LiftMate into wall receptacle to enable functions and recharge battery.
- 3. Always use a replacement battery from Brewer. Never use any other battery which could cause damage to the unit or improper operation.
- 4. When not using the LiftMate, always keep the unit plugged into a wall receptacle to keep the battery charged. Leaving the unit unplugged for an extended period of time (i.e. several months) will allow the battery to discharge, causing premature battery failure.

### **LiftMate Battery Disposal**



- Do not disassemble the LiftMate battery.
- Please dispose of the LiftMate battery according to your local regulations for lead-acid storage batteries.

#### **OPERATION**

#### General



Do not use the LiftMate in an explosive or oxygenrich atmosphere. To do so will result in an explosion or fire.

## WARNING

If the LiftMate malfunctions, immediately remove your hand from the controls, press one of the "Emergency Stop" buttons, unplug the power cord from the electrical receptacle, and assist the patient from the unit. If LiftMate continues to malfunction, call for service. Do not attempt to repair LiftMate yourself.

## **WARNING**

Keep personnel and equipment clear of LiftMate before initiating movement to avoid personal injury or damage to the equipment.

## **A**CAUTION

The hand pendant is moisture resistant and runs on low voltage, eliminating shock hazards. However, to avoid temporary or permanent damage to the hand pendant, do not immerse in water or liquids.

## **A** CAUTION

Keep foreign objects away from hand pendant. To avoid accidental operation, be sure the hand pendant is NOT positioned between the LiftMate and any other object. Failure to do so could result in unwanted motion and possible injury to patient or operator, or damage to LiftMate or exam table.

NOTE: For optimum LiftMate performance, allow the unit to reach room temperature before operating.

NOTE: The LiftMate is not designed for continuous operation. The control system includes a thermal overload safety switch to protect from overheating. If the unit is operated continuously causing the control to exceed its allowable operating temperature, the thermal overload safety switch will shut off. If normal operation ceases, do not attempt to operate the unit. Allow the unit to cool for 10-15 minutes before attempting to use again. The thermal overload switch will automatically reset when it has reached a safe operating temperature.

NOTE: Each control function will automatically stop moving when either the UP or DOWN travel limit is reached. If the hand pendant is pressed with travel at its limit, the actuator will not operate. Sensors prevent the actuator motor from operating when travel limit has been reached, preventing wear of the actuator.





## **OPERATION (Continued)**

#### Moving the LiftMate

The LiftMate moves about easily on four extendable/retractable casters.




Figure 4. Caster Extend/Retract Button

To extend casters depress the "PUSH AND HOLD TO MOVE" button on the hand pendant. See Figure 4. Casters will extend allowing the LiftMate to be moved to the desired location. The button must be held to keep casters extended. Releasing the "PUSH AND HOLD TO MOVE" button will cause casters to retract, lowering the LiftMate onto the four base feet providing a stable unit for the patient to step onto.



#### CAUTION

- Do not lower LiftMate onto wet, or slippery surfaces, or onto objects that may cause imbalance
- Make sure operator and patients feet are clear of unit before lowering.
- Make sure path of travel is free of obstructions that may cause unit to tip.

## Patient Handling with the LiftMate (Positioning the LiftMate and raising the patient)

- 1. Extend casters. Figure 5.
- 2. Position the back of LiftMate against foot end or side of exam table. Figure 6.
- 3. When in position allow casters to retract by releasing the button.
- 4. Assist patient by having them walk forward onto LiftMate platform.




Figure 7. Raising the patient on the LiftMate

- 5. Once patient is on LiftMate assist them in turning around so their back is toward exam table, and they are grasping the platform handrail. Figure 7.
- 6. Press "UP" on the hand pendant to raise patient to the height that is best for seating them. Figure 8.
- 7. Seat patient onto exam table.
- 8. Platform may be left in the "UP" position. To lower platform press "DOWN" on the hand pendant, Figure 9 next page.
- 9. Note: LiftMate may be left in position at the foot end of exam table, or moved out of the way depending upon procedure or preference of clinician.






## **OPERATION (continued)**

# Patient Handling with the LiftMate (Lowering the Patient)

- Roll the back of the LiftMate against foot end or side of exam table, depending on position of patient on the table.
- 2. Ensure patient's feet are clear of the platform and any portion of the exam table as it is raised.
- 3. Make sure the platform is raised by pushing the "UP" button, Figure 8.
- 4. Have patient slide forward to stabilize feet onto platform.
- 5. Patient can then come to a standing position on platform and grasp handrail.
- 6. Lower platform all the way down, Figure 9, and assist patient off of LiftMate.



## **Emergency Stops**




Figure 10. Emergency Stop Locations

Emergency Stops are located on the outer right-hand and outer left-hand Shrouds, Figure 10. In the unlikely event of unintended movement of the Platform, depressing the Emergency Stop, Figure 11, will cause all Platform movement to cease. Have a qualified technician inspect the unit prior to using. Rotating the Emergency Stop Switch clockwise, Figure 12, will reset it to normal operation. Note: The Emergency Stops only deactivate the Platform. The casters will still deploy with the Emergency Stop button depressed.

#### **MAINTENANCE**

#### **Preventative Maintenance**

## **A** CAUTION

Failure to perform periodic inspections of the LiftMate could result in personal injury or equipment damage.

- Periodically inspect the electrical cord to ensure it is free of cuts or damage.
- Periodically inspect the electrical cord to ensure it is free of cuts or damage.
- Inspect the mechanical functions to ensure satisfactory operation.
- Ensure that cord hooks are not loose. Remove outer right shroud and tighten if necessary.
- Check shroud screws to make sure they are present and tightened securely.
- Check platform bumper for damage, and to ensure that it is secured to the edge of the platform. Reattach or replace as necessary.
- Make sure the covers located at the back of the platform when raised, are engaged with the guides, and move freely when the platform is raised up and down.

### Cleaning



The shroud material is resistant to most medicinal type stains, but may be damaged by solvents and dyes. Remove any spilled fluids from the shrouds, painted surfaces or mat immediately.

- Clean the LiftMate weekly, wiping the painted metal and plastic surfaces with a clean, soft cloth. If desired, mild cleaners may be used.
- Clean the mat immediately after contact with any fluids or gels. Use a mild soap and rinse with clear water. Avoid the use of harsh chemicals as they can permanently damage the finish. To prevent mat from peeling do not allow it to remain wet.

#### **TROUBLESHOOTING**

#### Casters

All casters will not extend or retract. This may indicate a low battery condition. Pressing any function on the Hand Pendant will cause "Low Battery" light on Hand Pendant to illuminate, and beeping sound to occur. Charge battery. Note: plugging LiftMate into receptacle will resume all functions in a low battery condition. If this action does not resume functionality contact Brewer Customer Service at 1-888-Brewer1 (1-888-273-9371).

One caster will not extend or retract. Contact Brewer Customer Service at 1-888-Brewer1 (1-888-273-9371).

**Casters are difficult to roll.** Lay LiftMate onto its back on a carpeted or protective surface that will not damage the finish. Check casters for wear, debris or damage. Clean or replace as needed. See the Service Parts list for replacement kit number.

Casters causing marks on floor. Over time casters can get embedded with dirt redepositing it onto flooring. Lay LiftMate onto its back on a carpeted or protective surface that will not damage the finish. Clean casters with soap and water. Use a fine stiff wire brush with just enough force to remove dirt (use only if necessary). Use this opportunity to check casters for wear or damage. Replace as needed. See parts list for replacement kit number.





## **TROUBLESHOOTING (Continued)**

#### **Platform**

#### Platform will not raise or lower

- Battery low. Pressing any function on Hand Pendant will cause "Low Battery" light on Hand Pendant to illuminate and beeping sound to occur. Charge battery. Note: plugging LiftMate into receptacle will resume all functions in a low battery condition.
- Emergency Stop button(s) pushed in. Turn both Emergency Stop buttons clockwise to unlock. Retry raising or lowering platform.
- This may be due to lift actuators being out of sync. Reset LiftMate by performing the following steps. \*Note:
   when pressing two buttons simultaneously to perform a reset they must be pushed at exactly the same time.
   It may take several attempts to initiate reset.
- If performing the above steps does not resume functionality contact Brewer Customer Service at 1-888-Brewer1 (1-888-273-9371).
- Press both the "UP" and "Down" buttons on the hand pendant simultaneously and hold for a 10 beep count emanating from the LiftMate. When the10 beeps are complete, a second cycle of beeps with a longer pause between them will emanate from the LiftMate. It is during this second cycle of beeps that the LiftMate platform can be moved. Press the "Down" button on the hand pendant to ensure that it is lowering correctly. If it is lowering correctly bring platform to its lowest position. LiftMate lift actuators are now in sync. Double check by raising platform to its full up position.

#### **Mobility**

#### LiftMate will not roll

- Make sure to press and hold the "Push and Hold to Move" button on the hand pendant to keep casters extended for mobility.
- Battery low. Pressing any function on Hand Pendant will cause "Low Battery" light on Hand Pendant to illuminate, and beeping sound to occur. Charge battery. Note: plugging LiftMate into receptacle will resume all functions in a low battery condition.
- If performing the above steps does not resume functionality contact Brewer Customer Service 1-888-Brewer1 (1-888-273-9371).





## **TROUBLESHOOTING (Continued)**

### LiftMate Operates Only When Plugged In

- A. If the battery's ability to hold a charge has decreased over time, the battery requires replacement.
- B. If battery has suddenly failed without warning the battery may have become disconnected. Remove the left outer cover to check battery connection at the plug in jack. If the connection is tight, and the battery is still inoperable, replace the battery.

#### LiftMate Fails to Operate Even When Plugged In

Sudden failure of all functions is indicative of no power at the wall receptacle or failure of the control box. Plug a lamp or other device known to operate into the receptacle to ensure power is available. If no power is available plug LiftMate into wall receptacle proven to have power. Check to see if LiftMate functions resume operation. If problem persists, contact Brewer Customer Service at **1-888-Brewer1 (1-888-273-9371)** for a replacement control box.

#### **Rubber Feet**

The rubber feet are easily replaced. Lay LiftMate onto its back on a carpeted or protective surface that will not damage the finish. Replace feet onto ends of legs by pressing all the way on and hold. A slight bump will protrude from the center of the foot. Pushing this bump in will cause the conical shaped catch on the inside of the foot to hook into the receiving hole in the leg. If there is difficulty getting the catch to hook, a rounded device of sufficient diameter (3/16") or larger such as a ball end Allen wrench can be inserted into the hole and pushed in. **DO NOT USE A POINTED OR SHARP OBJECT SUCH AS A PHILLIPS OR FLAT BLADED SCREWDRIVER.** See the Service Parts list for replacement kit number.

#### **Platform Mat**

If the platform mat has become excessively soiled, worn or is peeling, replace with the Platform Mat Replacement Kit. See the Service Parts list for replacement kit number.

#### Platform Bumper

If the platform bumper has detached it can be pushed back onto the edge of the platform. If the bumper will not stay attached replace with the Platform Bumper Kit. See the Service Parts list for replacement kit number.
